At this time, a presentation was made to council by Germain Proulx of Accent Electronic Controls Inc. Mr. Proulx spoke briefly about the company and then provided an overview of OSCAR Road patrol system. The system is tablet based and is compliant with the minimum maintenance standards. He provided a PowerPoint presentation to members of council and allowed members to ask questions throughout the presentation. He indicated that system comes with an annual fee of \$4,000.00 per year and there is a set-up fee of \$1,300.00. Mr. Proulx discussed the benefits of the system in regards to liability issues involving the Township and indicated that Townships have presented this system in court and it has been accepted by a Judge. Mr. Proulx indicated that it would be necessary to purchase a tablet and new phones for staff in order to effectively use this system. He also provided a brief demonstration on how the system operates. With no further questions, the Reeve thanked Mr. Proulx for attending the meeting.

After Mr. Proulx left the meeting, members of council then discussed the benefits of the OSCAR Road Patrol system for the Township. After some discussion, the following resolution was adopted:
