Reeve Donaldson then called the regular meeting of Council to Order at 1:00 p.m. on the above noted date, with all members present with the exception of Libby Clarke. The meeting was opened with a minute of silence. A declaration of potential conflict of interest was declared by Councillor Martin in regards to closed meeting item number 4.

THAT Council approves the Minutes of the December 06, 2011 Council meeting,

Staff Sgt. Dan Rajsic from the Bancroft Detachment of the O.P.P. attended to speak with Council. Staff Sgt. Rajsic provided Council with an information sheet. He spoken about the cost of policing, occurrence data, clearance rates and collisions in the North Hastings area and in the Township. The Reeve thanked the Staff Sgt. for attending and updating Council about the police services for this area.

Ross Wood on behalf of Rally of the Tall Pines and the Black Bear Rally attended to speak with Council. Mr. Wood had 3 separate requests for Council to consider. The first request was in regards to the annual request for the Tall Pines Rally. He advised there were no issues with the 2011 year. Mr. Wood indicated that the Rally would like to use the same part of Old Hastings Road for Rally of the Tall Pines. The Rally is scheduled to be held on November 24, 2012. The second request was in regards to the Black Bear Rally. Mr. Wood requested use of the

Community Centre to use as Headquarters for Friday evening and all day Saturday, where the Rally would do registration, various meetings and radio headquarters. He wanted to make sure there would be enough parking for approximately 70 vehicles. He requested washroom facilities, a room large enough for the awards banquet – 80 – 100 people and a catering service for 80 – 100 meals. The third request from Mr. Wood was in regards to requesting assistance with road repairs to the Sleeper Lake forest access road (aka Green Lake). Mr. Wood indicated that for many years, this road was used as a stage in the rally but because of deterioration to the road and MNR budget cuts, the road could no longer be used. Mr. Wood requested assistance from the Township by way of road grading. He indicated that he felt the estimated work time would be 3 days. Mr. Wood further indicated that the Rally would cover the costs related to the material for the road.

Much discussion incurred and it was decided that all matters would be deferred to the next meeting of Council for further discussion.

The final delegate was Anna Bragg. Ms. Bragg attended to speak with Council in regards to concerns pertaining to a neighbor and the township owned shoreline road allowance. Ms. Bragg provided Council with a copy of a recently completed survey of her property together with pictures taken from her property which showed concerns pertaining to the shoreline road allowance. Ms. Bragg indicated that her neighbours had cut trees on the shoreline road allowance and had left items and a boat on the shoreline road allowance. Ms. Bragg outlined some concerns she had experienced with her neighbours and she requested permission from Council to purchase the shoreline road allowance. Much discussion incurred.
