3. The land owners contact Crowe Valley Conservation Authority to review the Right-Of-Way and abide by any direction stipulated by the Conservation Authority;
4. All costs pertaining to the Agreement to be registered on title and any Conservation Authority directions shall be the responsibility of the land owners and not the Township.
